1. Examination of the suspected Patients/ Persons who are kept in home isolation.
2. To help the District Administration in mapping the Containment Zone as well as Buffer Zone, in case a Positive COVID-19 Patient is identified.
3. After examination of the suspected cases, the RRT will classify them into category A, B and C and samples shall be collected and sent to AMCH, Dibrugarh for testing COVID-19 accordingly.
4. After identification of positive cases, The RRT will do the listing, accordingly and update the report everyday, under the supervision of the IDSP-DSO, Jorhat.
