Detailed guidelines with respect to Quarantine, either at home or in an institution, have already been issued. In order to bring more clarity, flowcharts are enclosed herewith depicting the processes to be followed:

- a) When a person is put under facility/ institutional quarantine (Annexure-A),
- b) When a person is put under home quarantine (Annexure- B),
- c) When patients discharged from isolation are kept under home/facility quarantine (Annexure- C).

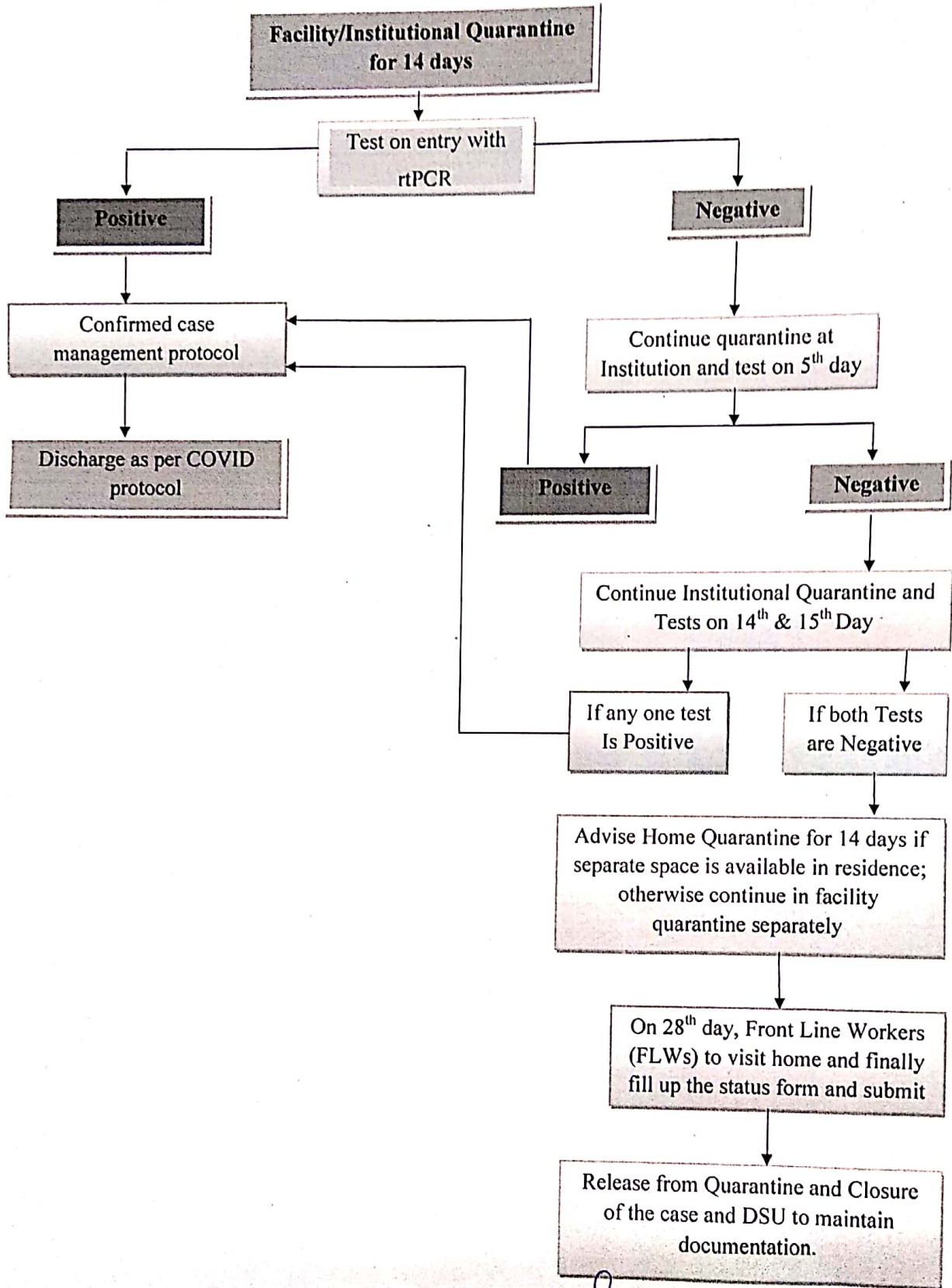

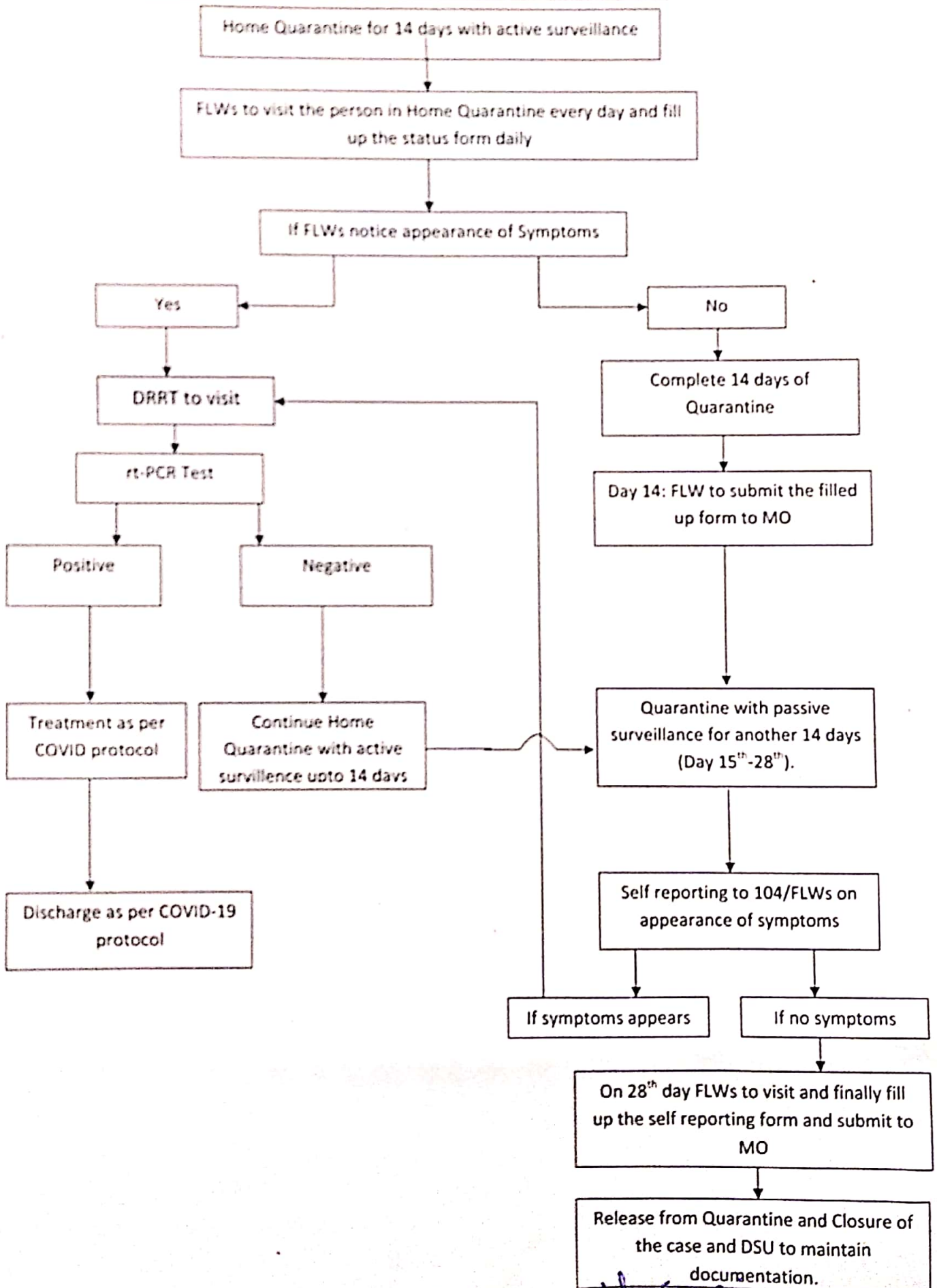

WHEN A PERSON IS PUT UNDER FACILITY/INSTITUTIONAL QUARANTINE



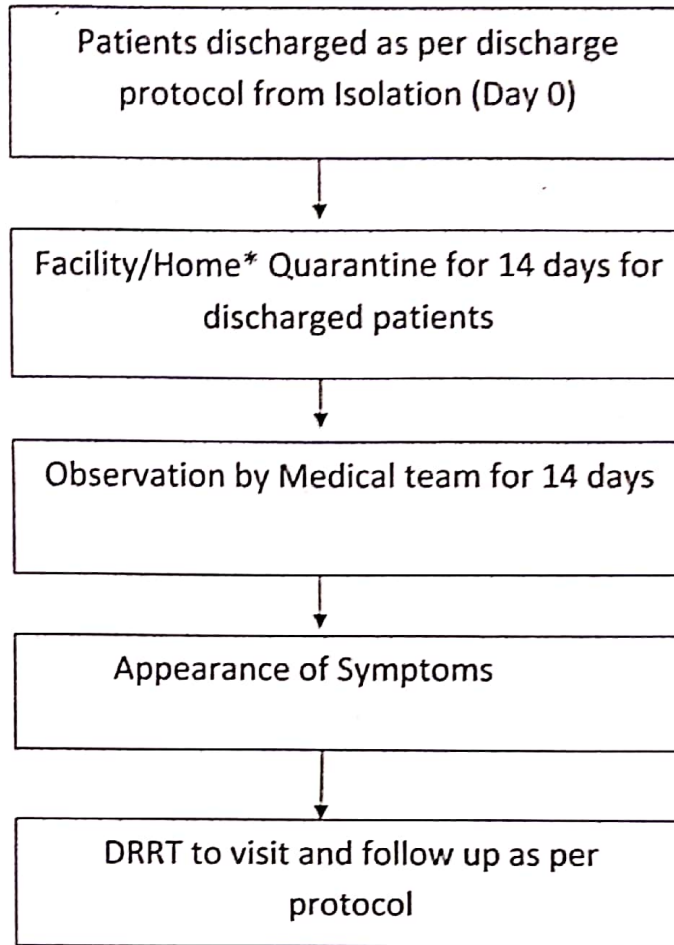
