


ORDER

In pursuance of order of the Ministry of Home Affairs, Govt. of India vide No. 40-3/2020-DM-1(A) dated 03/04/2020(4th Addendum) permission is hereby accorded to operate the Tea Industries including plantations from 12/04/2020 in the district of Lakhimpur with the following conditions:

1. Tea Estates/ Factories/Small Tea Growers of Lakhimpur district will operate from tomorrow i.e. 12/04/2020 and continue with the activities like skiffing, plucking, manufacturing etc according to the status of standing tea bushes of the particular garden.
2. All tea gardens will operate with maximum of 50% workers and employees on roster basis.
3. Movement of workers of a Tea Gardens will be restricted within the premises of the garden only, no outsiders will be allowed to enter the garden premises except for emergency services.
4. All tea Garden authorities will ensure strict compliance of social distancing of atleast 2 metre and proper hygiene practices of handwashing/sanitizing frequently among the workers and employees. Adequate liquid handwash/soaps/sanitizers and clean water will be arranged by the tea garden authorities.
5. Wearing of Mask by the labourers/ employees is compulsory in the tea gardens. No tea estate will be allowed to operate if masks are not worn by the labourers/employees. Also, hand gloves should be used by the labourers/ employees.
6. All tea Gardens should maintain a daily roster of their employees.
7. Permission has to be obtained from the district administration for vehicle movement outside tea garden.

This permission may be withdrawn at any time without assigning any reason thereof.


