


Role and Responsibilities of the Centre in-charge

1. Centre in-charge will ensure that each passengers are accommodated in a single room with attached toilet. Couples and families may be accommodated in the same room.
2. Centre in-charge shall maintain details of passengers housed in hotels on daily basis in a register.
3. Centre in-charge shall ensure that foods (breakfast, lunch & dinner) are provided to the passengers housed in the hotel in time. He shall strictly monitor the quality of food. Any lapse in this regards shall be viewed seriously.
4. Centre in-charge shall be in close co-ordination with ADC (DM), Phn 8761059654 and Circle Officer, Bihpuria Revenue Circle, Phn. 7086592978 regarding any requirements for the passengers housed in the hotels.
5. In case of any medical emergency, Centre in-charge will inform the doctor in-charge of the centre immediately and shall keep in close liaison with the medical team.
6. Centre in-charge will ensure regular cleaning of the toilet and room of the hotels where the passengers are housed. In this regards, he will keep close co-ordination with the Joint Director of Health Services, Phn. 9957510949.
7. Centre in-charge will ensure sanitization of the hotel rooms after discharge of the passengers from the hotel. In this regards, he will inform Executive Engineer, PHE, North Lakhimpur Division (7002193908) for sanitization.
