**No. HLA 248/2020/80** – In view of a large number of people coming from outside the state due to relaxation in lockdown, the Governor of Assam is pleased to constitute **Zonal Screening Centre Discharge Boards** to advise release or otherwise from institutional quarantine at zonal screening locations **ONLY** of all such persons arriving into Assam at these places viz. Kokrajhar, Guwahati, Tezpur, Jorhat and Silchar.

**A. For Guwahati**, the zonal screening discharge board is constituted with the following members:

- 1) Shri M. Bordoloi, ADC, Kamrup, i/c Zonal Screening Centre, Sarusajai, Guwahati.
- 2) Shri K. Talukdar, Deputy Secretary, H&FW Deptt & Dy. CEO, AAA,
- 3) Dr. G. Saikia, Joint DHS, Kamrup (M),
- 4) Dr. Rahul Sarma, Consultant, NHM,
- 5) Dr. Mahmuda Nasrin, DSO, IDSP, Kamrup (M).


**B. For Kokrajhar**, the zonal screening discharge board is constituted with the following members:

- 1) Deputy Commissioner, Kokrajhar or his representative not below the rank of Additional Deputy Commissioner,
- 2) Deputy Secretary, Health & Family Welfare, BTAD,
- 3) Joint DHS, Kokrajhar,
- 4) DSO, IDSP, Kokrajhar.

**C. For Sonitpur, Jorhat and Cachar**, the zonal screening discharge board is constituted with the following members:

- 1) Deputy Commissioner concerned or his representative not below the rank of Additional Deputy Commissioner,
- 2) HOD of community medicine or his representative not below the rank of Associate Professor, of respective medical college,
- 3) Joint DHS of concerned district,
- 4) DSO, IDSP of concerned district.


The concerned Deputy Commissioners shall issue specific orders in this regard with intimation to the Government.



The committee shall meet on a daily basis and communicate its decision to all concerned for immediate follow up action.

The committee shall follow the procedure as laid in the flowchart enclosed.

This order comes into force with immediate effect.



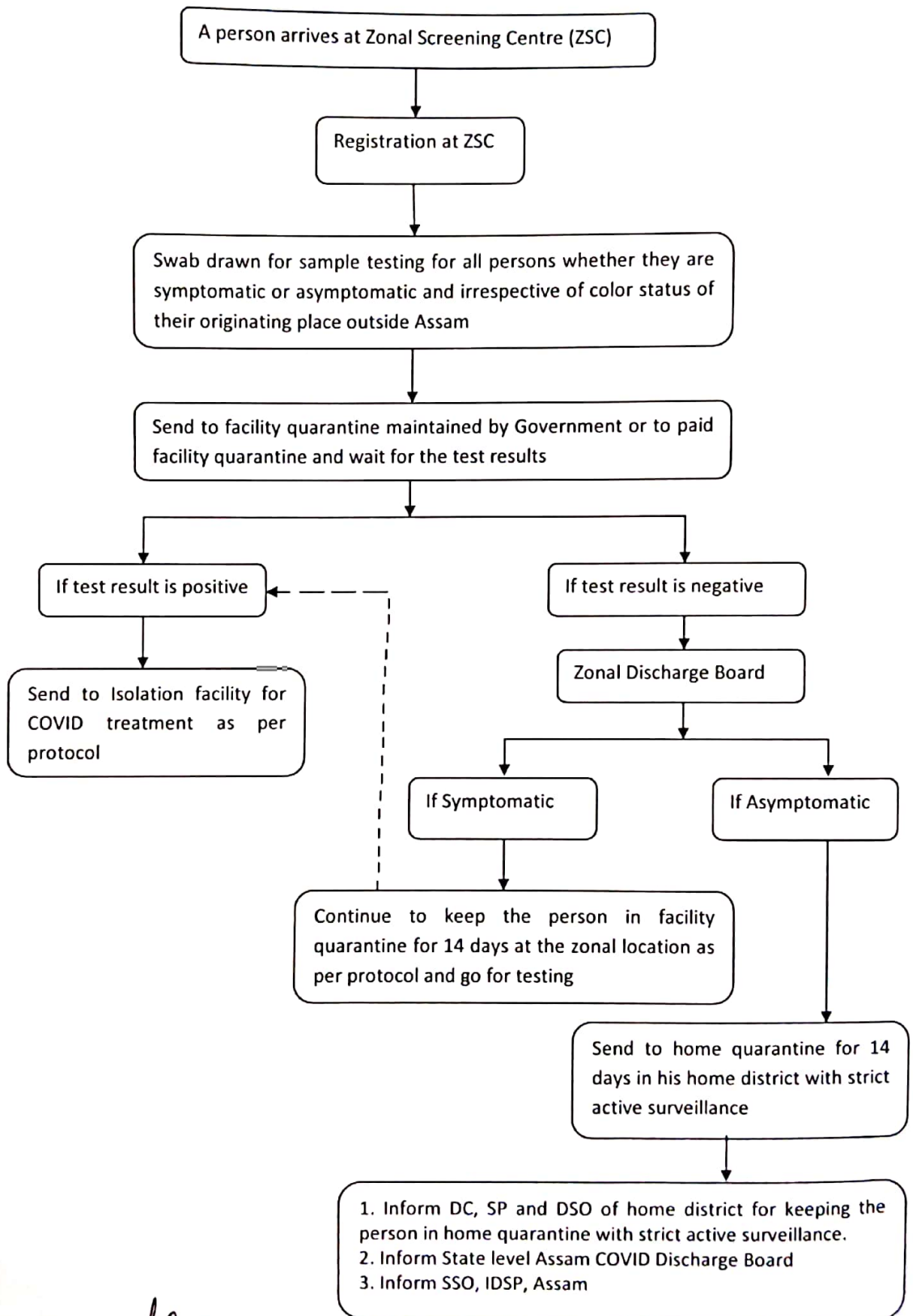
