ORDER

In partial modification of this Office Order No. MJ/DDMA/ASDMA-Letter/2017-18/121; dated 19th March' 2020 and in view of potential threat of the COVID-19 virus to the human, measures are being taken by the District Disaster Management Authority to create awareness amongst the general public and to prevent the spreading of the virus in the district.

Therefore, it is required to take immediate preventive or mitigation step by the concerned for containing the spread of the virus & loss of lives in the district.

Considering the facts, in exercise of the powers conferred by Section 34 of the District Management Act. 2005 I, **Sri Bikram Kairi**, IAS, District Magistrate, Majuli do hereby direct that the following guidelines are issued in-cases where a guest is quarantined in a Hotels/Lodges/Guest Houses or any kind of accommodation the following steps shall be taken:-

1. The Hotel Manager shall ensure that the rooms have attached bathroom facility.
2. The quarantined guests are to be given a leaflet wherein Do's and Don'ts on COVID-19 is mentioned to maintain personal hygiene and to contain the spread of the virus.
3. The soiled linen, cloths, towel shall not be mixed with those of others and shall be disinfected with bleach, washed properly and sun-dried and also before next use.
4. Bleach solution must be used to clean furniture, wash basin and toilets etc.
5. The windows of the room shall be kept open during daytime and the room should be mopped with bleach solution.
6. The room shall be provided with hand wash/sanitizers/soap etc. for personal hygiene of the guests.
7. Meals to such guests shall be served in their rooms only and preferably in disposable plates or containers. Disposable plates/containers used for this purpose should be disposed of as bio-medical waste in deep burial pits.
8. The housekeeping and room service staff must use personal protective equipment such as mask, hand gloves etc. to serve the guest. Further they shall maintain a minimum of 2 meter distance from the guest while serving.
9. The security personnel of the hotel shall ensure that the movement of these guests is restricted to the allotted room only.
10. No visitors other than the Doctors/Medical Officer Designated/ Paramedics or authorized officers shall be allowed inside the hotel/lodge/guest house to meet any of the quarantined person.
11. The hotel management shall also observe the movement of these guests and in case of any violation by the guest, shall inform the District Administration immediately.
12. In case of any security requirement, the Hotel Management will intimate to Police Authorities for necessary action.
