ORDER

In pursuance of the Assam State Disaster Management Authority, Govt of Assam vide Order No. ASDMA.24/2020/Part-1/43, dated 3rd May' 2020 received from the Hon'ble Chief Secretary Govt. of Assam and in connection with prevention of spread of Novel Corona Virus-19 (COVID-19) disease and to take all precautionary measures to stop virus spreading in the community, I, Sri Bikram Kairi, IAS, District Magistrate, Majuli District in exercise of the powers conferred upon me by Section 144 of Cr. P.C. and having been convinced, do hereby restrict movement of all kinds of vehicle/persons etc. in entire Majuli District from 6 PM to 6 AM and thereby impose CUREW in the aforesaid area.

This order will however not be applicable to MAGISTRATE ON DUTY/MEDICAL SERVICES ON DUTY/POLICE ON DUTY/SECURITY PERSONNEL/ FIRE SERVICES/ OFFICIALS ENGAGED IN DISTRICT ADMINISTRATION/ EMERGENCY RESPONSE FOR RESTORING TELECOM AND ELECTRICITY.

This order comes into force with immediate effect and will remain in-force till 17th May' 2020.

Any violation of this order is punishable Under Section 188 IPC.
